I. Death Benefit:

\$67,000 Covered Injury & Illness Death Benefit - This benefit is payable if an Insured Person sustains a covered injury or illness that directly causes the loss of life.

II. Impairment Benefits:

Up to \$67,000 Dismemberment, Loss of Speech, Hearing Benefit, Vision, Cosmetic Disfigurement from Burns, Paralysis Benefit.

III. Income Protection Benefits:

\$250 minimum weekly total disability benefit. Paid in addition to any benefit from any source. Plus, up to \$250 per week for partial disability or permanent physical impairment. Benefits are payable for up to 5 years while the insured person is totally disabled.

IV. Accident Death & Dismemberment:

Up to \$20,000 On-Duty benefits and up to \$10,000 Off-Duty benefits. Pays in addition to the \$67,000 death benefit above.
